
**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY CHARGE  
PART OF THE TARIFF RELATING TO FUEL FOR JAMSHORO POWER COMPANY LIMITED**


1. Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Limited (hereinafter "JPCL"), adjustments have been made in the fuel cost component of energy charge part of tariff of JPCL, due to variation in fuel prices for the month of June 2019. The block-wise revised fuel cost components of JPCL, on account of variation in furnace oil prices are indicated hereunder:



3. CPPA (G) to ensure that all payments are consistent with the tariff determination.



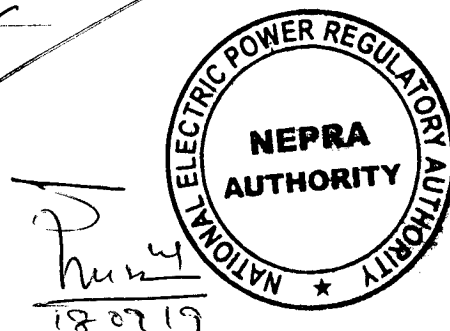
