
**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY CHARGE PART OF THE
TARIFF RELATING TO RLNG W.E.F. 1ST SEPTEMBER 2018 & 1ST OCTOBER 2018 FOR JAMSHORO POWER COMPANY
LIMITED**


1. Pursuant to the decision of Authority dated October 19, 2018 notified vide S.R.O No. 330(I)/2019 in the matter of request filed by Jamshoro Power Company Limited (JPCL) for modification in the existing mechanism of fuel cost component on account of utilization of Re-Gasified Liquefied Natural Gas (RLNG), the fuel portion of energy charge part of tariff of JPCL is required to be adjusted for variation of RLNG price(s).
2. Oil & Gas Regulatory Authority (OGRA) has notified provisional RLNG price(s) for Sui Southern Gas Company Limited (SSGCL) for its distribution network vide its notifications dated September 12, 2018 and October 9, 2018 for the month of September 2018 and October 2018, respectively. Based on OGRA's notification, fuel cost components on RLNG of JPCL have been revised. The revision has been made on provisional basis and final fuel cost component(s) shall be made after notification of final RLNG price(s) determined by OGRA.
3. The block-wise revised fuel cost components for period of September 2018 & October 2018 are indicated hereunder and shall be immediately applicable to the units delivered basis:



5. CPPA-G to ensure that all payments are consistent with the tariff determination.

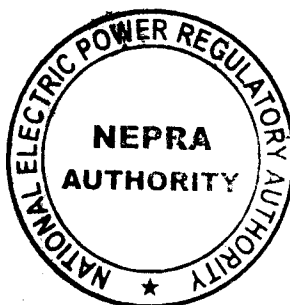


