DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY CHARGE PART OF THE TARIFF RELATING TO GAS W.E.F. 27TH SEPTEMBER 2018 AND 1ST JULY 2019 FOR JAMSHORO POWER COMPANY LIMITED. (JPCL)

- 1. Pursuant to the Authority's decision dated September 1, 2015 notified vide S.R.O No. 1142(I)/2015 dated November 17, 2015 in the matter of Motion for Leave for Review file by Jamshoro Power Company Limited (JPCL) against the determination of the Authority dated September 12, 2014 and decision of the Authority dated October 19, 2018 notified vide S.R.O 330(I)/2019 in the matter of modification in the existing mechanism of fuel cost component, the fuel portion of energy charge part of tariff of JPCL is required to be adjusted for variation of gas price(s).
- 2. Oil & Gas Regulatory Authority (OGRA) has notified gas price(s) vide its notifications dated October 4, 2018 and June 29, 2019 effective September 27, 2018 and July 1, 2019, respectively. Based on OGRA's revised notified gas prices and in accordance with the adjustment mechanism stipulated in the decision of the Authority, fuel cost components have been revised. The block-wise revised fuel cost components are indicated at Annex-I and shall be immediately applicable on units delivered basis.
- 3. The revised fuel cost components of energy charge part of tariff attached as **Annex-I** are to be notified in the official gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 4. CPPA-G to ensure that all payments are consistent with the tariff determinations.
