## DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMNT OF INCOME TAX PAID BY JAMSHORO POWER COMPANY LIMITED (JPCL)

Jamshoro Power Company limited (hereinafter "JPCL") requested to the Authority to approve the amounts of Rs. 15,000,000/- (Rupees Fifteen Million) and Rs. 37,161,000/- (Rupees Thirty-Seven Million One Hundred Sixty-one Thousand) on account of income tax for the 2<sup>nd</sup> and 4<sup>th</sup> quarters of the FY 2019-20, paid to the Federal Government under Section 147 of the Income Tax Ordinance, 2001. JPCL in support of its claim submitted the Computerized Tax Payments Receipt IT-20190930-0014-1461001 & IT-20200612-0021-1178511 dated September 30, 2019 & June 12, 2020, respectively.

- 2. As per section 11.3(c) of the decision of the Authority dated September 1, 2015 notified vide S.R.O 1142(I)/2015 dated November 17, 2015 in the matter of Motion for Leave for Review against the determination of Authority dated September 12, 2014, in case JPCL is obliged to pay any tax, the exact amount paid shall be reimbursed as per existing practice. Considering that the request of the JPCL is in line with the decision of the Authority, JPCL is hereby allowed to claim an amount of Rs. Rs. 52,161,000 (Fifty-two Million One Hundred Sixty-one Thousand) from the Power Purchaser i.e. CPPA(G) on account of tax amount paid to the Federal Government.
- 3. The above decision of the Authority is to be notified in the Official Gazette in accordance with provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
- 4. CPPA(G) to ensure that all payments are consistent with the tariff determination.
