





3. CPPA (G) to ensure that all payments are consistent with the tariff determination.

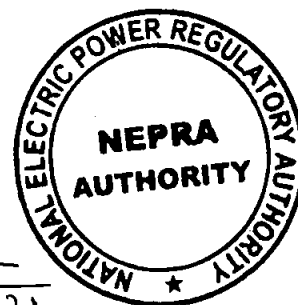
