





Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Limited (hereinafter "JPCL"), adjustment has been made in the fuel cost components of energy charge part of tariff of JPCL, due to variation in fuel price(s) for the month of September 2021. 

3. CPPA (G) to ensure that all payments are consistent with the tariff determination.

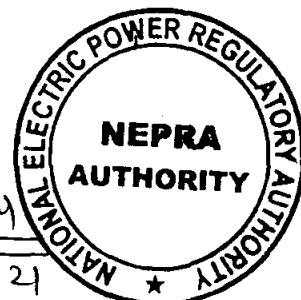
