



JAMSHORO POWER COMPANY LIMITED**



Pursuant to the Authority's decision dated September 01, 2015 notified vide S.R.O 1142(I)/2015 dated November 17, 2015 in respect of generation tariff for Jamshoro Power Company Limited (hereinafter "JPCL"), based on information submitted by JPCL, adjustment has been made in the fuel cost components of energy charge part of tariff, due to variation in the furnace oil price(s) for the month of July 2022. The block-wise/unit-wise revised fuel cost components of JPCL are indicated hereunder which shall be immediately applicable to the units delivered during the month:



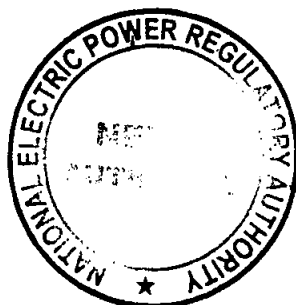

3. CPPA (G) to ensure that all payments are consistent with the tariff determination.


