2. Summary of decision is:

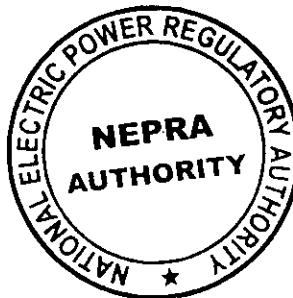
- Adjustment on account of fuel price variation for furnace oil on August 31, 2007.

The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.

Energy Charge Part of the Tariff Relating to Fuel for NPGCL**


