
Dear Sir,

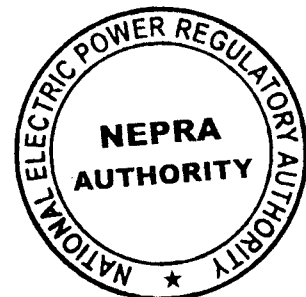


**DECISION OF THE AUTHORITY RELATING TO THE TARIFF
ADJUSTMENT OF NORTHERN POWER GENERATION COMPANY
LIMITED (NPGCL) FOR VARIATION IN CPI ON JULY 01, 2008**

Pursuant to NEPRA's determination in Case No. NEPRA/TRF-46/NPGCL-2005, the tariff of Northern Power Generation Company Limited (NPGCL) is subject to adjustment in Escalable Component of Capacity Purchase Price to compensate for variation in the Consumer Price Index (CPI). The tariff has therefore been accordingly revised w.e.f. July 01, 2008. The detail of Capacity Charge revised after adjustment is attached herewith for notification in the official gazette:


The revised tariff shall become immediately applicable as mentioned in S.R.O 997(I)/2006 dated September 20, 2006, subject to any difference in the tariff notified by the Federal Government as per section 31 (4) of the National Electric Power Regulatory Authority Act, 1997. In case the notified rate is different from the one already allowed for the immediate application the requisite adjustment in tariff shall be made as soon as possible but not later than the succeeding billing month.
