
2. Summary of decision is:




Pursuant to the Authority's decision dated December 14, 2006 in respect of specified rate allowed to Northern Power Generation Company Ltd. (NPGCL), for sale of power from rental basis power plants to CPPA for procurement on behalf of ex-WAPDA DISCOs, adjustments have been made in the fuel cost charge part of variable charge subsequent to change in gas prices occurring on January 01, 2008. The fuel cost charge part of the variable charge for both Sharaqpur and Bhikki G/S Additional Blocks has been revised to **Rs. 2.8395 per kWh** and should be notified in the official gazette accordingly.


