**Subject: Decision of the Authority in the Matter of Adjustment of the Fuel Cost Charge Part of the Variable Charge for Northern Power Generation Company Ltd. (NPGCL) regarding Power Procured from Rental Basis Power Plants (Case No. NEPRA/TRF-63/NPGCL-2006) - Intimation of Decision of Tariff pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997)**

Please find enclosed the decision of tariff (01 page) of the Authority in respect of adjustment of fuel cost charge part of the variable charge regarding power procured from Rental Basis Power Plants (i.e. Sharaqpur and Bhikki) for Northern Power Generation Company Ltd. (NPGCL) in Case No. NEPRA/TRF-63/NPGCL-2006.

2. Summary of decision is:

- Adjustment on account of fuel price variation for gas on July 01, 2009.

3. The decision is being intimated to the Federal Government for the purpose of notification of adjustment in the approved tariff through the official Gazette pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.

3. In view of above, Decisions of the Authority against Case No. NEPRA/TRF-63/NPGCL-2006 as communicated vide letters No. NEPRA/TRF-63/NPGCL-2006/3216-18 dated 02.08.2007, No. 6181-83 dated 13.02.2008 and No. 389-391 dated 22.01.2009 need to be notified prior to the notification of the attached adjustment in respect of NPGCL.

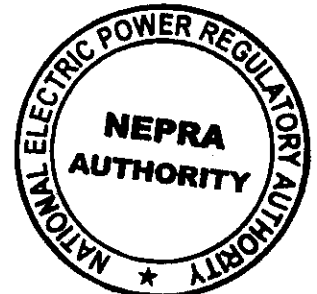


**Decision of the Authority in the Matter of Adjustment of the Fuel Cost Charge Part of the Variable Charge for Northern Power Generation Company Limited (NPGCL) regarding Power Procured from Rental Power Plants.**


Pursuant to the Authority's decision dated July 03, 2007 in respect of specified rate allowed to Northern Power Generation Company Ltd. (NPGCL), for sale of power from rental power plants to CPPA for procurement on behalf of ex-WAPDA DISCOs, adjustment has been made in the fuel cost charge part of variable charge subsequent to change in gas price occurring on July 01, 2009. The fuel cost charge part of the variable charge for both Sharaqpur and Bhikki G/S Additional Blocks has been revised from Rs. 3.9459/kWh to Rs. 3.7700/kWh w.e.f July 01, 2009. The revised fuel cost charge for NPGCL Rental Power Plant is indicated hereunder:




The fuel cost component accordingly stands modified to the extent of Rs. 3.7700/kWh for both Sharaqpur and to Bhikki G/S Additional Block and is being intimated to be notified in pursuance of sub-section (4) of section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997).


