3. Please note that revised schedule of tariff attached to the decision as Annex-I is required to be notified in the official Gazette.

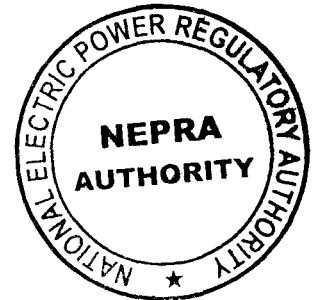

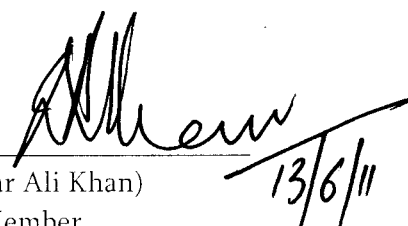
**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY

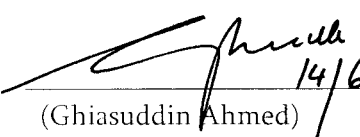

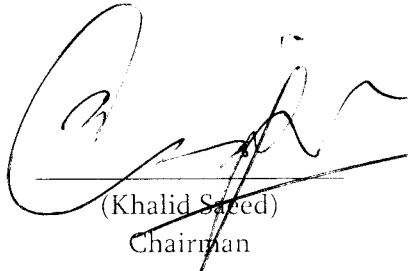

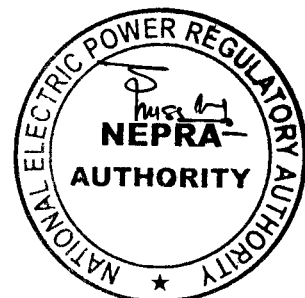
