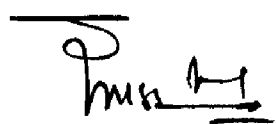

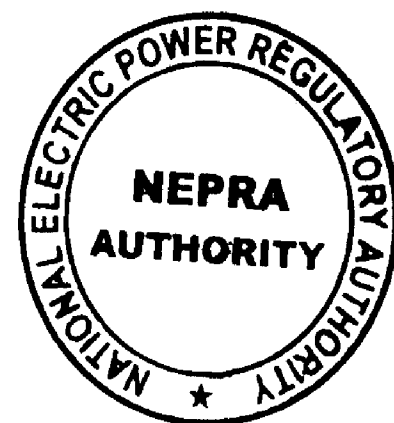

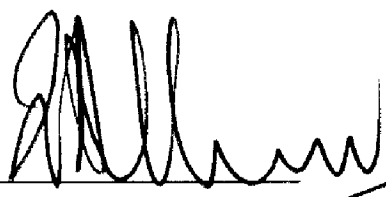
DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN THE ENERGY

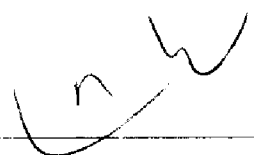
Pursuant to the decision of the Authority dated 13<sup>th</sup> April 2009 notified vide S.R.O 669(1)/2010 dated 20<sup>th</sup> July 2010 in respect of generation tariff for 62 MW Gulf Rental Power of Northern Power Generation Company Ltd. (NPGCL), adjustment has been made in the fuel part of energy charge subsequent to change in furnace oil prices for 2<sup>nd</sup> fortnight of March 2011.
