

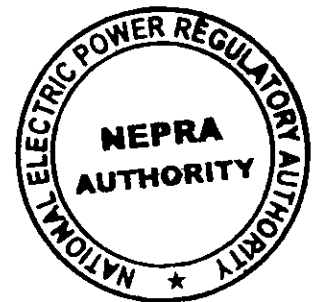



(CASE NO. NEPRA/TRF-106/NPGCL-2008)


