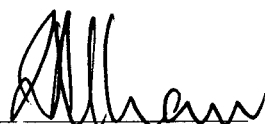

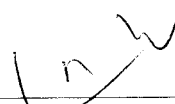

With effect from 30.4.2011	15.0783

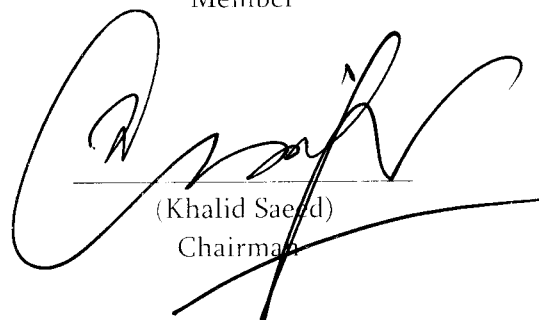

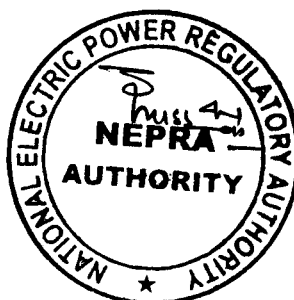
