

With effect from 28.2.2011	13.2592



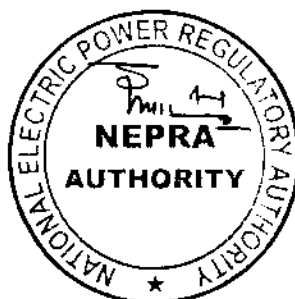
