




**Decision of the Authority in the Matter of Adjustment of the Energy Charge Part
of the Tariff Relating to Fuel for Northern Power Generation Company Ltd.**


Pursuant to paragraph 61 (iii) of the Authority's decision dated 20.09.2006 in respect of generation tariff for Northern Power Generation Company Ltd.
