## DECISION OF THE AUTHORITY RELATING TO THE TARIFF ADJUSTMENT OF NORTHERN POWER GENERATION COMPANY LIMITED FOR VARIATION IN CPI, W.E.F JULY 01, 2013

Pursuant to the Authority's determination in Case No. NEPRA/TRF-46/NPGCL-2005, the tariff of Northern Power Generation Company Limited (NPGCL) is subject to adjustment in Escalable Component of Capacity Purchase Price to compensate for variation in the Consumer Price Index (CPI). NPGCL vide letter No. FD/NPGCL/TRF/3953-54 dated 6th June 2013 requested the Authority for adjustment of the Escalable Component part of Capacity Charge part of tariff w.e.f July 01, 2013. In accordance with the decision of the Authority dated May 15, 2012, the NPGCL current adjustment has been made on the basis of revised references. The revised Escalable part of Capacity Purchase Price of NPGCL tariff w.e.f. July 01, 2013 is indicated hereunder:
