
**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE ENERGY

GENERATION COMPANY LTD. (CASE No. NEPRA/TRF-46/NPGCL-2005)**


Pursuant to paragraph 61 (iii) of the Authority's decision dated May 02, 2006 in respect of generation tariff for Northern Power Generation Company Ltd. (NPGCL), adjustments have been made in the fuel part of energy charge subsequent to change in furnace oil prices for the month of July 2014. The block-wise revised fuel cost component for NPGCL applicable w.e.f July 15, 2014 and July 31, 2014 is indicated hereunder:




