DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT REQUEST MADE BY NORTHERN POWER GENERATION COMPNAY LIMITED (NPGCL) ON ACCOUNT OF INCOME TAX PAID TO THE FEDERAL GOVERNMENT

Northern Power Generation Company Limited (NPGCL) requested to the Authority to approve the amount of Rs. 300,000,000/- (Rupees Three Hundred Million), on account of 1.25% minimum tax on turnover for the 3rd quarter of the tax year 2018, paid to the Federal Government under Section 147 of the Income Tax Ordinance. NPGCL in support of its claim submitted the Computerized Tax Payment Receipts IT-20180329-0378-1263319, IT-20180328-0374-1256947, IT-20180328-0374-1256945, IT-20180328-0374-1256946 and IT-20180328-0374-1256944.

- 2. As per section 11.3(IV) of the decision of the Authority dated 19th October 2016 in the matter of Motion for Leave for Review, in case NPGCL is obliged to pay any tax, the exact amount paid shall be reimbursed as per existing practice. Considering that the request of the NPGCL is in line with the decision of the Authority, NPGCL is hereby allowed to claim an amount of Rs. 300,000,000/- (Rupees Three Hundred Million), from the Central Power Purchasing Agency Guarantee Limited on account of tax amount paid to the Federal Government.
- 3. The revised capacity part of NPGCL tariff relating to tax attached as **Annex-I** is to be notified in the official Gazette in accordance with provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
