
**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE ENERGY

GENERATION COMPANY LIMITED.**


Pursuant to the Authority's decision dated October 19, 2016 notified vide S.R.O. No. 702(I)/2017 dated July 21, 2017 in the matter of Motion for Leave for Review against Authority's tariff determination for FY 2014-15 to 2016-17 for Northern Power Generation Company Limited (NPGCL), adjustment has been made in the fuel part of energy charge subsequent to changes in furnace oil price for the 2<sup>nd</sup> fortnight of January 2019. The block-wise/unit-wise revised fuel cost components for NPGCL are indicated hereunder:




