# DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE ENERGY CHARGE PART OF THE TARIFF RELATING TO GAS W.E.F. 27<sup>TH</sup> SEPTEMBER 2018 AND 1<sup>ST</sup> JULY 2019 FOR NORTHERN POWER GENERATION COMPANY LIMITED.

- 1. Pursuant to the Authority's decision dated October 19, 2016 notified vide S.R.O No. 702(I)/2017 dated July 21, 2017 in matter of Motion for Leave for Review against Authority's Determination of the generation tariff dated 22<sup>nd</sup> January 2016 for Northern Power Generation Company Limited (NPGCL) and decision dated October 19, 2018 notified vide S.R.O No. 329(I)/2019 in the matter of modification in the existing mechanism of fuel cost component, the fuel portion of energy charge part of tariff of NPGCL is required to be adjusted for variation in gas price(s).
- 2. Oil & Gas Regulatory Authority (OGRA) has notified gas price(s) vide its notifications dated October 4, 2018 and June 29, 2019 effective September 27, 2018 and July 1, 2019, respectively. Based on OGRA's revised notified gas prices and in accordance with the adjustment mechanism stipulated in the decision of the Authority, fuel cost components have been revised. The block-wise revised fuel cost components are indicated at Annex-I and shall be immediately applicable on units delivered basis.
- 3. The revised fuel cost components of energy charge part of tariff attached as **Annex-I** are to be notified in the official gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 4. CPPA-G to ensure that all payments are consistent with the tariff determinations.
