


Decision of the Authority in the Matter of Adjustment of the energy charge part of the tariff relating to fuel for 2nd Fortnight of June 2021 for Northern Power Generation Company Limited.

Pursuant to the Authority's decision dated October 19, 2016 for Northern Power Generation Company Limited (NPGCL), adjustment has been made in the fuel part of energy charge on account of variation in furnace oil price for the 2nd fortnight of June 2021. The block-wise/unit-wise revised fuel cost components for NPGCL are indicated hereunder:
