

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE
ADJUSTMENT FOR NORTHERN POWER GENERATION COMPANY LIMITED
FOR ITS POWER PROJECT OF GTPS FAISALABAD**

1. Pursuant to the decision of the Authority dated October 19, 2018 notified vide S.R.O No. 329(I)/2019 in the matter of request filed by Northern Power Generation Company Limited (NPGCL) for modification in the existing mechanism of fuel cost component on account of utilization of Re-Gasified Liquefied Natural Gas (RLNG) and decision of the Authority dated December 30, 2020 in the matter of tariff determination for NPGCL, the fuel cost components have been adjusted for variation in RLNG price(s). The revision has been made on provisional basis as per OGRA's determination of provisional RLNG weighted average price for SNGPL dated November 10, 2021. Final fuel cost components shall be determined after notification of final RLNG price by OGRA and submission of fuel invoice(s) by NPGCL. The revised fuel cost components on RLNG indicated hereunder shall be immediately applicable on unit delivered basis:

2. The above referred revised fuel cost components of energy charge part of tariff attached as **Annex-I** are to be notified in the official gazette, in accordance with the provision of Section 31(7) of Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.

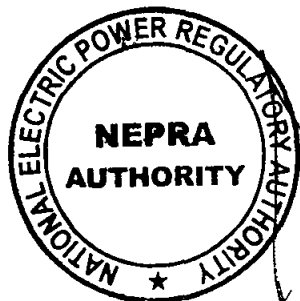
