DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT REQUEST MADE BY NORTHERN POWER GENERATION COMPNAY LIMITED (NPGCL) ON ACCOUNT OF INCOME TAX PAID TO THE FEDERAL BOARD OF REVENUE (FBR)

- 1. Northern Power Generation Company Limited (hereinafter refer as "NPGCL") requested for approval of reimbursement of advance income tax amount of Rs. 12,812,254/- (Rupees Twelve Million Eight Hundred Twelve Thousand Two Hundred Fifty-Four), on account of 1.5% minimum tax on turnover for the 3rd quarter of the tax year 2021, paid to the Federal Board of Revenue (FBR) under Section 147 of the Income Tax Ordinance. NPGCL in support of its claim submitted the Computerized Tax Payment Receipt (CPR) IT-20210330-0101-1776566. NPGCL further submitted that out of Rs. 34,416,970/- tax paid amount, an amount of Rs. 21,604,717/- related to Nandipur Power Plant and remaining amount of Rs. 12,812,254/- pertains to NPGCL old block(s).
- 2. As per the Section 11.3(IV) & 24(III) of the decisions of the Authority dated 19th October 2016 & 30th December 2020, in case NPGCL is obligated to pay any tax, the exact amount paid shall be reimbursed as per existing practice.

Order

- 3. Considering that the request of the NPGCL is in line with the decisions of the Authority, NPGCL is hereby allowed to claim an amount of Rs. 12,812,254/- (Rupees Twelve Million Eight Hundred Twelve Thousand Two Hundred Fifty-Four), from the Central Power Purchasing Agency Guarantee Limited on account of tax amount paid to FBR.
- 4. The above decision of the Authority is to be notified in the official Gazette in accordance with provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
