

INSURANCE COMPONENT OF TARIFF FOR ZORLU ENERJI PAKISTAN LIMITED**


Pursuant to the decision of the Authority dated February 20, 2015 in the matter of tariff adjustment of Zorlu Energy Pakistan Limited (ZEPL) at Commercial Operation Date (COD) and review motion decision dated December 1, 2015; in accordance with the requisite indexations/adjustment mechanism stipulated in the above referred decision(s) of the Authority and in accordance with the Schedule 8 of the EPA, the insurance component of tariff of ZEPL has been revised for the periods from 30th July 2015 to 29th July 2016 and 30th July 2016 to 29th July 2017. The approved revised tariff of insurance component indicated in Annex-I is allowed to charge for delivery of electricity to the power purchaser during the specified periods.

2. The above revised tariff component attached as **Annex-I** is to be notified in the official gazette, in accordance with the provision of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.


