In supersession to NEPRA's earlier letter No. NEPRA/R/ADG(Trf)/TRF-243/5140-44 dated 18.04.2024, please find enclosed herewith the subject Decision of the Authority (total 02 Pages) in the matter of reimbursement of 7.5% Withholding Tax on Dividend for the Financial Year ended June 30, 2022 and June 30, 2023 in respect of Act Wind Private Limited in Case No. NEPRA/TRF-243/TWEPL-2013.

3. The Decision is being intimated to the Federal Government for the purpose of notification in the official Gazette pursuant to Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 within 30 days from the intimation of this Decision. In the event the Federal Government fails to notify the subject tariff Decision or refer the matter to the Authority for reconsideration, within the time period specified in Section 31(7), then the Authority shall notify the same in the official Gazette pursuant to Section 31(7) of NEPRA Act.

DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT OF WITHHOLDING TAX ON DIVIDENDS FOR ACT WIND (PVT.) LIMITED.

The Authority issued a decision dated November 21, 2013 in the matter of application of Act Wind (Pvt.) Limited ("AWPL") opting for Upfront Tariff. Subsequently, a revised decision dated May 2, 2014 was issued wherein the financial close deadline for Upfront Tariff was modified. Later, the Authority issued a decision dated January 22, 2016 regarding one-time adjustment of base amount of debt service for USD/PKR parity of the Upfront Tariff for AWPL. Commercial Operations Date (COD) was achieved by AWPL on October 08, 2016. Subsequently, the Authority vide decision dated April 09, 2021 in the matter of application filed by CPPA-G adjusted the aforesaid decision dated November 21, 2013 notified through S.R.O 719(I)/2021dated June 04,2021.

2. The Authority in its collective and joint wisdom considering all aspect decided with consensus as under; which will be hereafter called as decision of the Authority in the matter

"AWPL requested for the reimbursement of Rs. 120,175,872 on account of 7.5% Withholding Tax ("WHT") on dividend for the financial year ended June 30, 2022 and FY 30, 2023. The Authority has considered the request of AWPL and decided to approve the available amount of Rs. 103,197,189 to be reimbursed by the power purchaser to AWPL."

- 3. The instant decision along with Annexure-I is to be notified in the official gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 4. CPPA-G to ensure that all the payments are consistent with tariff determination.


