DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT OF WITHHOLDING TAX ON DIVIDEND FOR FOUNDATION WIND ENERGY 1 LIMITED

The Authority issued Tariff Determination of Foundation Wind Energy 1 Limited (FWEL-I) on March 16, 2012 and decision of the Authority on motion for leave for review filed by FWEL-I was issued on May 23, 2012. Subsequently, the Authority issued decision in the matter of tariff adjustment of FWEL-I at Commercial Operation Date (COD) i.e. April 11, 2015 on October 27, 2016.

- 2. In accordance with the decision(s) referred above, FWEL-I requested for the reimbursement of Rs. 52,500,000 on account of 7.5% withholding tax ("WHT") on interim cash dividend pertaining to the period from July 01, 2021 to December 31, 2021. The Authority has considered the request of FWEL-I and decided to allow WHT on dividend of Rs. 52,500,000 for the period from July 01, 2021 to December 31, 2021. This approved amount shall be reimbursed by the power purchaser to FWEL-I.
- 3. The instant decision is to be notified in the official gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 4. CPPA-G to ensure that all the payments are consistent with tariff determination.
