**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE  
COMPONENT OF TARIFF OF FOUNDATION WIND ENERGY-I LIMITED**

Pursuant to the decision of the Authority dated October 27, 2016 in the matter of tariff adjustment of Foundation Wind Energy-I Limited (FWEL-I) at commercial operation date (COD) and corrigendum decision dated December 2, 2016, FWEL-I has requested insurance indexation based on insurance cost of Rs. 87,393,958 and corresponding component of tariff of Rs. 0.6048/kWh for the period from January 01, 2026 to December 31, 2026.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

“Based on the information provided by the FWEL-I, adjustment in insurance component for the period January 01, 2026 to December 31, 2026 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder.”

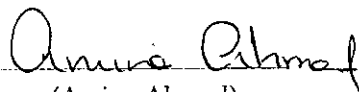

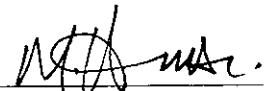
\*Revised Insurance premium has been worked out on the basis of actual premium which is 0.28 % of the EPC cost and is less than the benchmark cost of 1.35 % of the EPC cost.

3. The revised insurance component of tariff is to be notified in the official Gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997(XL of 1997).

4. CPPA-G to ensure that all the payments are consistent with tariff determination.
