

COMPONENT OF TARIFF OF FOUNDATION WIND ENERGY-II (Private) LIMITED**


Pursuant to the decision of the Authority dated June 9, 2016 in the matter of tariff adjustment of Foundation Wind Energy-II (Private) Limited (FWEL-II) at commercial operation date (COD), the insurance component of tariff of FWEL-II based on actual insurance cost for the period from July 01, 2020 to June 30, 2021 has been revised as under:

July 01, 2019 to June 30, 2020 (for comparison only)	54,050,719	0.3761



- CPPA-G to ensure that all the payments are consistent with tariff determination.


