DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR HYDROCHINA DAWOOD POWER (PVT.) LIMITED

The Authority issued the decision in the matter of application of Hydrochina Dawood Power (Pvt.) Ltd (HDPPL) opting for Upfront Tariff for Wind Power Projects on April 23, 2014. HDPPL successfully achieved its commercial operations date on April 04, 2017. Pursuant to the tariff indexation/ adjustment mechanisms devised in the decision of the Authority dated April 23, 2014, the relevant components of tariff of HDPPL for the quarter July-September, 2018 have been revised on account of US CPI, exchange rate and LIBOR variation as apparent in **Annex-I**.

2. The above referred revised tariff components attached **Annex-I** are to be notified in the official gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
