

ADJUSTMENT OF TARIFF FOR HYDROCHINA DAWOOD POWER (PVT.) LIMITED**





3. CPPA-G to ensure that all the payments are consistent with tariff determination.

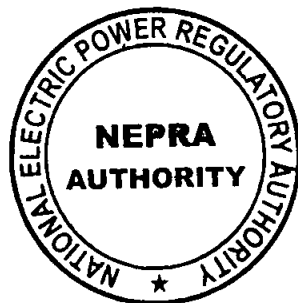

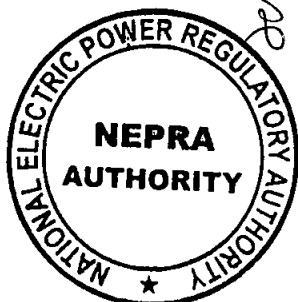
