<u>DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/</u> <u>ADJUSTMENT OF TARIFF FOR HYDROCHINA DAWOOD POWER (PVT.) LIMITED</u>

Pursuant to the decision of the Authority dated April 23, 2014 in the matter of Application of Hydrochina Dawood Power (Pvt.)
