

TARIFF FOR JHIMPIR POWER (PRIVATE) LIMITED**


Pursuant to grant of "Upfront Tariff dated June 24, 2015 for Wind Tariff Power Projects" to Jhimpir Power (Private) Limited (JPPL) vide Authority's decision dated August 11, 2015 notified through S.R.O. No 1259(I)/2015 dated December 16, 2015 and the decision of the Authority dated November 19, 2018 in the matter of tariff adjustment of JPPL's tariff at Commercial Operation Date (COD) notified vide S.R.O. No 399(I)/2019 on March 21, 2019, the relevant tariff components of JPPL in respect of quarter April-June, 2020 have been revised on account of US CPI, exchange rate and LIBOR variation in accordance with the requisite indexation/adjustment mechanism stipulated in the above referred decision(s) of the Authority indicated in Annex-I.


2. The adjusted/ indexed tariff attached as **Annex-I** is to be notified in the official gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
3. CPPA-G to ensure that all the payments are consistent with tariff determination.






