## DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF TARIFF OF MASTER GREEN ENERGY LIMITED

Pursuant to the decision of the Authority dated December 08, 2022 in the matter of tariff adjustment of Master Green Energy Limited (MGEL) at Commercial Operation Date (COD) and notified vide S.R.O No 59(I)/2023 dated January 19, 2023, the insurance cost and corresponding component of tariff of MGEL for the periods from August 21, 2021 to August 20, 2022 and August 21, 2022 to August 20, 2023 is given as under:

Revised Insurance premium works out to be 0.4 % of the approved EPC cost.
