
Dear Sir,


**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE



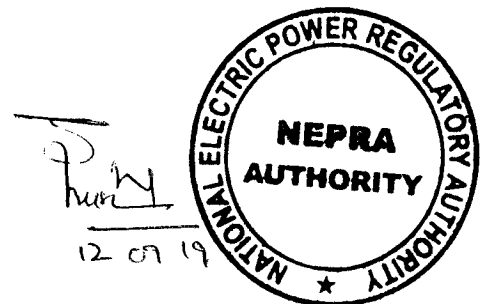

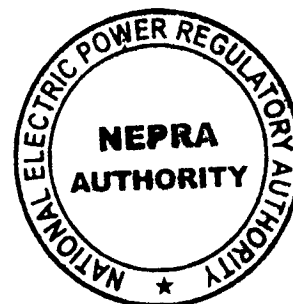
