
Dear Sir,

Please find enclosed herewith the decision of the Authority (01 Page) regarding adjustment in insurance component of Sachal Energy Development (Pvt.) Ltd.'s tariff for the period April 11, 2022 to April 10, 2023 in Case No. NEPRA/TRF-207/SEDPL-2007.

2. The Decision is being intimated to the Federal Government for the purpose of notification in the official Gazette pursuant to Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 within 30 days from the intimation of this Decision. In the event the Federal Government fails to notify the subject tariff Decision or refer the matter to the Authority for reconsideration, within the time period specified in Section 31(7), then the Authority shall notify the same in the official Gazette pursuant to Section 31(7) of NEPRA Act.

April 11, 2022 to April 10, 2023	82,369,984	0.6034

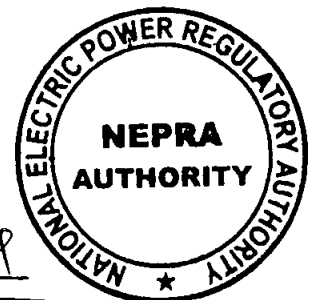
2. The claims of insurance with respect to motor insurance, health and life insurance not been considered as the same are not covered in the scope of insurance as given in the EPA.
