**DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT OF 7.5%
WITHHOLDING TAX ON DIVIDEND FOR SACHAL ENERGY DEVELOPMENT (PVT) LTD**

1. Pursuant to the decision of the Authority dated June 01, 2018 in the matter of tariff adjustment of Sachal Energy Development (Pvt.) Limited (SEDPL) at Commercial Operation Date (COD) notified vide S.R.O No 36(l)/2016 dated on November 06, 2018. SEDPL has requested for reimbursement of WHT on dividend of Rs. 120,000,000.
2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:
"Based on the information provided by the SEDPL, Authority has considered the request of SEDPL and decided to allow WHT on dividend of Rs. 120,000,000 pertaining to FY 23-24. This approved amount shall be reimbursed by the power purchaser to SEDPL".
3. The instant decision along with **Annex-I** is to be notified in the official Gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
4. CPPA-G to ensure that all the payments are consistent with tariff determination.

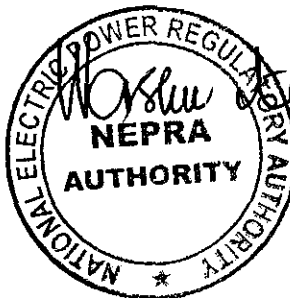
