DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT OF 7.5% WITHHOLDING TAX ON DIVIDENDS FOR SAPPHIRE WIND POWER COMPANY LIMITED

The Authority granted Upfront Tariff to Sapphire Wind Power Company Limited (SWPCL) vide decision dated November 21, 2013. Later, the Authority issued a decision dated May 02, 2014 to the extent of change in the financial close deadline for Upfront Tariff. The Authority revised the installed capacity of SWPCL from 49.5 MW to 52.8 MW vide its decision dated May 26, 2015. Commercial Operations Date (COD) was achieved by SWPCL on November 22, 2015.

2. In accordance with the decision(s) referred above, SWPCL requested for the reimbursement of withholding tax (WHT) on interim dividends for the financial years ending June 30, 2021 and June 30, 2022. The Authority has considered the request of SWPCL and decided to approve the total reimbursement of Rs. 35,175,000 pertaining to the financial years ending June 30, 2021 and June 30, 2022 in respect of WHT to SWPCL by the power purchaser.

3. The instant decision is to be notified in the official gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act.
