

**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF  
TARIFF OF THREE GORGES SECOND WIND FARM PAKISTAN LIMITED**

Pursuant to the decision of the Authority dated January 08, 2019 in the matter of tariff adjustment of Three Gorges Second Wind Farm Pakistan Limited (TGSWFPL)'s tariff at Commercial Operation Date (COD) notified vide S.R.O. No 423(I)/2019 on April 03, 2019, the revised insurance amount and corresponding insurance component of tariff of TGSWFPL for the period from June 20, 2022 to June 19, 2023 is indicated as under:

June 20, 2022 to June 19, 2023	54,840,971	0.3613

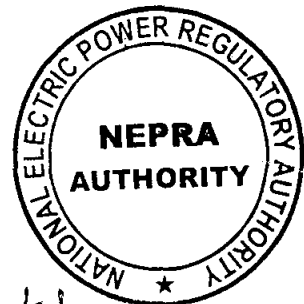
