Pursuant to the decision of the Authority dated January 08, 2019 in the matter of tariff adjustment of TGSWFPL's tariff at Commercial Operation Date (COD) notified vide S.R.O. No 423(I)/2019 on April 03, 2019, the revised insurance amount and corresponding insurance component of tariff of TGSWFPL for the period from June 20, 2023 to June 19, 2024 is indicated as under

"Based on the information provided by the TGSWFPL, adjustment in insurance component for the period June 20, 2023 to June 19, 2024 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is
