DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF TARIFF OF THREE GORGES SECOND WIND FARM PAKISTAN LIMITED

No 423(I)/2019 on April 03, 2019, the revised insurance amount and corresponding insurance component of tariff of TGSWFPL for the period from June 20, 2024 to June 19, 2025 is indicated as under
