**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT  
OF TARIFF OF THREE GORGES FIRST WIND FARM PAKISTAN (PVT) LIMITED**

Pursuant to the decision of the Authority dated January 22, 2016 in the matter of tariff adjustment of Three Gorges First Wind Farm Pakistan (Pvt.) Limited (TGFWFPL) at Commercial Operation Date (COD) notified vide S.R.O No 361(1)/2016 dated April 20, 2016 and in the matter of Motion for Leave for Review dated October 28, 2016 against the Decision of the Authority at COD, the revised insurance amount and corresponding insurance component of tariff of TGFWFPL for the period from November 26, 2024 to November 25, 2025 is indicated as under

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

“Based on the information provided by the TGFWFPL, adjustment in insurance component for the period November 26, 2024 to November 25, 2025 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder which shall be immediately applicable.”
