Limited (TGFWFPL) at Commercial Operation Date (COD) notified vide S.R.O No 361(1)/2016 dated April 20, 2016 and in the matter of Motion for Leave for Review dated October 28, 2016 against the Decision of the Authority at COD, the revised insurance amount and corresponding insurance component of tariff of TGFWFPL for the period from November 26, 2024 to November 25, 2025 is indicated as under
