## <u>Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge</u> Part of Tariff for Three Gorges First Wind Farm Pakistan (Private) <u>Limited (TGF)</u>

- 1. Pursuant to the decisions of the Authority dated January 22, 2106 in the matter of Tariff Adjustment at Commercial Operation Date (COD) notified vide S.R.O 361(I)/2016 dated April 20, 2016 and in the matter of Motion for Leave for Review against the Decision of the Authority at Commercial Operation Date (COD) dated 28th October 2016, in accordance with the requisite mechanism stipulated in the above referred decision(s) of the Authority and in accordance with the Schedule VIII of the EPA, the insurance component of capacity charge part of tariff has been revised on the basis of insurance premium net of Sales Tax.
