**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT
OF TARIFF OF THREE GORGES THIRD WIND FARM PAKISTAN (PVT) LIMITED**

Pursuant to the decision of the Authority dated January 08, 2019 in the matter of tariff adjustment of Three Gorges Third Wind Farm Pakistan (Pvt) Limited (TGTWFPL) at Commercial Operation Date (COD) notified vide S.R.O. No 424(I)/2019 on April 03, 2019, TGTWFPL has requested for the revised insurance component of Rs. 0.4468/kWh based on insurance premium of Rs. 67,802,587 for the period from June 09, 2026 to June 08, 2027.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the TGTWFPL, adjustment in insurance component for the period June 09, 2026 to June 08, 2027 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder."

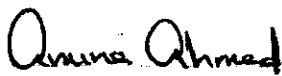

* Revised Insurance premium has been worked out on the basis of actual premium which is 0.26 % of the FPC cost and is less than the benchmark cost of 1 % of the FPC cost.

3. The revised insurance component of tariff is to be notified in the official Gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XI. of 1997).

4. CPPA-G to ensure that all the payments are consistent with tariff determination.
