**DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF  
TARIFF FOR TRICON BOSTON CONSULTING CORPORATION (PVT.) LIMITED, PROJECT-C**


Pursuant to grant of "Upfront Tariff dated June 24, 2015 for Wind Tariff Power Projects" to Tricon Boston Consulting Corporation (Pvt.) Limited, Project-C (TBCCPL-C) vide Authority's decision dated May 13, 2016 notified through S.R.O. No 269 (I) 2017 dated April 17, 2017 and the decision of the Authority dated April 01, 2019 in the matter of tariff adjustment of TBCCPL-C's tariff at Commercial Operation Date (COD) notified vide S.R.O. No 862 (I) 2019 on July 05, 2019, the relevant tariff components of TBCCPL-C in respect of quarters from July-September, 2020 have been revised on account of US CPI, exchange rate and LIBOR variation in accordance with the requisite indexation/adjustment mechanism stipulated in the above referred decision(s) of the Authority indicated in Annex-I.


2. The adjusted/ indexed tariff attached as **Annex-I** is to be notified in the official gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.

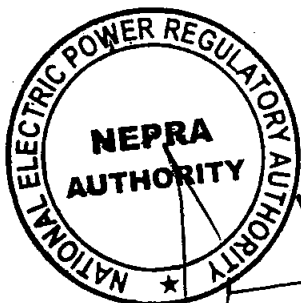


