**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR TRICON BOSTON CONSULTING CORPORATION PVT LTD-A.**

Pursuant to the indexations/adjustment mechanism stipulated in the decision of the Authority dated April 01, 2019 in the matter of tariff adjustment of Tricon Boston Consulting Corporation Private Limited-A (TBCCPL-A) at Commercial Operation Date (COD) notified vide S.R.O. No 862 (I) 2019 on July 05, 2019, TBCCPL-A submitted the request for the revised insurance component of tariff for the period from November 22, 2023 to November 21, 2024 is tabulated as hereunder,

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

“Based on the information provided by the TBCCPL-A, adjustment in insurance component for the period November 22, 2023 to November 21, 2024 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable.”



Revised Insurance premium works out to be 0.49% of the approved EPC cost.

3. The revised insurance component of tariff is to be notified in the official gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.

4. CPPA-G to ensure that all the payments are consistent with tariff determination.


