Pursuant to grant of "Upfront Tariff dated June 24, 2015 for Wind Tariff Power Projects" to Tricon Boston Consulting Corporation (Pvt.) Limited, Project-B (TBCCPL-B) vide Authority's decision dated May 13, 2016 notified through S.R.O. No 270(I) 2017 dated April 17, 2017 and the decision of the Authority dated April 01, 2019 in the matter of tariff adjustment of TBCCPL-B's tariff at Commercial Operation Date (COD) notified vide S.R.O.
