


**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF



November 22, 2019 to November 21, 2020	36,849,341	0.2416

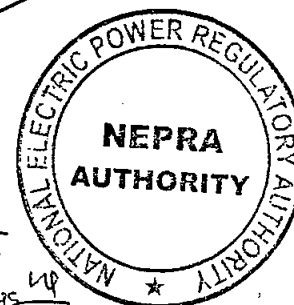
